Background and overview

An accreditation assessment site visit was undertaken between 11 and 14 June as part of the regular five-yearly cycle of visits to the University of Southern Queensland. The visit included two days at the Ipswich campus and one and a half days at the Toowoomba campus to meet with staff, students, external supervisors, and to inspect the Psychology clinics and other facilities. The psychology programs are offered by the School of Psychology and Counselling which is situated within the Faculty of Health, Engineering and Sciences. The Head of the School is Professor Lorelle Burton, who reports to the Executive Dean of the Faculty. The School offers a range of undergraduate programs that include a major in psychology and these are offered on both campuses as well as externally. The majority of the undergraduate student cohort studies externally. The School offers a four-vear psychology sequence as well as a stand-alone Honours year. At the postgraduate level, the School offers a Master of Professional Psychology based at the Ipswich campus and a Master of Clinical Psychology based at the Toowoomba campus. The School has experienced a decline in student numbers over the past few years and as a result is reviewing both undergraduate and postgraduate programs with the aim of increasing the number of enrolled students and enhancing students' learning experiences. The School commissioned a significant external review of the two Master of Psychology programs in 2018 and results of this are informing a major revision to these programs for 2020 onwards. The School is well regarded for its provision of psychology education and training for regional and remote students. Psychology was awarded a five-star rating in the 2019 Good Universities Guide, with particularly strong ratings (90%+) for Teaching Quality, Learning Resources, and Overall Experience. The School also has outstanding research achievements, with the Psychology Field of Research achieving a five-star rating in the 2018 Excellence in Research Australia round. The School is also experiencing a period of planning for rejuvenation of their staffing after having experienced many staff losses recently in both planned and unplanned circumstances. The significantly reduced staff numbers appear to be having a predictably negative effect on the workloads and wellbeing of remaining staff, and the results of the USQ 2018 Employee Voice Engagement Survey have shown a decline compared to the previous year, although the School results remain higher than the University average.

- Remove reference to superseded APAC Standards, such as disallowance of Conceded passes in course specifications, and attributing compulsory attendance at residential schools for Honours students to APAC requirements.
- The online handbook for the Master of Clinical Psychology be corrected to remove reference to the need for supervisors to be a member of the APS College of Clinical Psychologists
