Background and overview

An accreditation assessment site visit was undertaken on the 11- 13 September as part of the regular five-yearly cycle of visits to Southern Cross University. The visit consisted of three days, the first at the Coffs Harbour campus and the next day and a half at the Gold Coast Campus. The visit included meetings with staff, and students, and to inspect other facilities. The psychology programs offered by the Discipline of Psychology, which is situated within the School of Health and Human Sciences is headed by Professor Peter Hassmen, who reports to the Dean of the School. The discipline offers a range of undergraduate programs that include a major in psychology and these are offered on both campuses.

The Assessment Team reviewed Southern Cross University's application for accreditation against the Accreditations Standards, using evidence obtained from the application, its appendices, SCU's website, additional information provided by the applicant, and information obtained during the course of the visit.

During the visit the Assessment Team met with:

- Professor Peter Hassmen, Professor of Psychology and Science Group Lead
- Professor lain Graham, Dean and Head of School of Health and Human Sciences
- The program coordinators and staff teaching in the various programs
- Twenty-Three undergraduate students
- Twenty Honours students
- Five members of the Administrative staff.

The Assessment Team toured the psychology related facilities located at Sothern Cross University campuses (Coffs Harbour and Gold Coast).



Key findings

This assessment found SCU staff provide excellent support to their students. The new Gold coast campus is well located and as this campus expands in student numbers there will need to be consideration given to moderation and consistency between the experience for the students with that of the Coffs Harbour campus. A further challenge of the Gold coast campus is mentoring and support for Gold Coast staff. With regard to the SCU programs inclusion of all aspects of program learning out comes, graduate competencies (at Level 2) and assessments need to be evidenced. Specifically, the inclusion of cultural responsiveness in learning outcomes and assessment needs addressing. Further work needs to be carried out on processes to include external input and benchmarking are undertaken and evidenced.

- 2. To ensure Standard 2 Academic governance and quality assurance, criterion 2.2 is met, the School must provide evidence to APAC that quality improvement processes use student evaluations of the programs and internal and external academic and professional peer review, including external benchmarking where programs and assessments may be compared to those offered by other providers.
- 3. To ensure Standard 2 Academic governance and quality assurance, criterion 2.3 is met, the School must provide evidence to APAC that there is relevant external and internal input into the design and management of the programs, including from representatives of the psychology profession, academic staff, professional psychology staff, prospective employers and students.
- 4. To ensure Standard 3 Program of study, criterion 3.2 is met, the School must provide evidence to APAC that program learning outcomes incorporate all graduate competencies for the relevant level(s) and form a coherent body of learning.
- 5.
