¹ This charge is applied **once** per provider, regardless of how many programs are offered in an online delivery mode.

² For physical site visits, providers are required to directly bear the full cost of economy travel (except offshore travel which will incur premium economy fares, or business fares where premium economy is not available), accommodation, transfers, meals and travel time for all assessment team members.
